		<b>ICCPR</b> International Covenant on Civil and Political Rights	<b>Show all articles</b> <b>6.1</b> Every human being has the inherent right to life. This right shall be protected by law. No one shall be arbitrarily deprived of his life.
		<b>ICESCR</b> International Covenant on Economic, Social and Cultural Rights	<b>Show all articles</b> <b>12.1</b> The States Parties to the present Covenant recognize the right of everyone to the enjoyment of the highest attainable standard of physical and mental health.
			<b>12.2</b> The steps to be taken by the States Parties to the present Covenant to achieve the full realization of this right shall include those necessary for: <b>12.2.a</b> The provision for the reduction of the stillbirth-rate and of infant mortality and for the healthy development of the child;
			<b>12.2.b</b> The improvement of all aspects of environmental and industrial hygiene;
			<b>12.2.c</b> The prevention, treatment and control of epidemic, endemic, occupational and other diseases;
			<b>12.2.d</b> The creation of conditions which would assure to all medical service and medical attention in the event of sickness.
		<b>CRC</b> Convention on the Rights of the Child	<b>Show all articles</b> <b>24.1</b> States Parties recognize the right of the child to the enjoyment of the highest attainable standard of health and to facilities for the treatment of illness and rehabilitation of health. States Parties shall strive to ensure that no child is deprived of his or her right of access to such health care services.
			<b>24.2</b> States Parties shall pursue full implementation of this right and, in particular, shall take appropriate measures: <b>24.2.a</b> To diminish infant and child mortality;
			<b>24.2.b</b> To ensure the provision of necessary medical assistance and health care to all children with emphasis on the development of primary health care;
			<b>24.2.c</b> To combat disease and malnutrition, including within the framework of primary health care, through, inter alia, the application of readily available technology and through the provision of adequate nutritious foods and clean drinking-water, taking into consideration the dangers and risks of environmental pollution;
			<b>24.2.d</b> To ensure appropriate pre-natal and post-natal health care for mothers;

			24.2.e To ensure that all segments of society, in particular parents and children, are informed, have access to education and are supported in the use of basic knowledge of child health and nutrition, the advantages of breastfeeding, hygiene and environmental sanitation and the prevention of accidents;
			24.2.f To develop preventive health care, guidance for parents and family planning education and services.
			24.3 States Parties shall take all effective and appropriate measures with a view to abolishing traditional practices prejudicial to the health of children.
		<b>CRPD</b> Convention on the Rights of Persons with Disabilities	<b>Show all articles</b> 10 States Parties reaffirm that every human being has the inherent right to life and shall take all necessary measures to ensure its effective enjoyment by persons with disabilities on an equal basis with others.
			25 States Parties recognize that persons with disabilities have the right to the enjoyment of the highest attainable standard of health without discrimination on the basis of disability. States Parties shall take all appropriate measures to ensure access for persons with disabilities to health services that are gender-sensitive, including health-related rehabilitation. In particular, States Parties shall:
			25.a Provide persons with disabilities with the same range, quality and standard of free or affordable health care and programmes as provided to other persons, including in the area of sexual and reproductive health and population-based public health programmes;
			25.d Require health professionals to provide care of the same quality to persons with disabilities as to others, including on the basis of free and informed consent by, inter alia, raising awareness of the human rights, dignity, autonomy and needs of persons with disabilities through training and the promulgation of ethical standards for public and private health care;
		<b>ICRMW</b> International Convention on the Protection of the Rights of All Migrant Workers and Members of Their Families	<b>Show all articles</b> 9 The right to life of migrant workers and members of their families shall be protected by law.
			28 Migrant workers and members of their families shall have the right to receive any medical care that is urgently required for the preservation of their life or the avoidance of irreparable harm to their health on the basis of equality of treatment with nationals of the State concerned. Such emergency medical care shall not be refused them by reason of any irregularity with regard to stay or employment.
		<b>UNDRIP</b> United Nations Declaration on the Rights of Indigenous Peoples	<b>Show all articles</b> 7.1 Indigenous individuals have the rights to life, physical and mental integrity, liberty and security of person.
			24.1 Indigenous peoples have the right to their traditional medicines and to maintain their health practices, including the conservation of their vital medicinal plants, animals and minerals. Indigenous individuals also have the right to access, without any discrimination, to all social and health services.
			24.2 Indigenous individuals have an equal right to the enjoyment of the highest attainable standard of physical and mental health. States shall take the necessary steps with a view to achieving progressively the full realization of this right.
		<b>DEVAW</b> Declaration on the Elimination of Violence against Women	<b>Show all articles</b> 3 Women are entitled to the equal enjoyment and protection of all human rights and fundamental freedoms in the political, economic, social, cultural, civil or any other field. These rights include, inter alia: 3.a The right to life;
		<b>European Social Charter</b> European Social Charter (Revised)	<b>Show all articles</b> Part II The Parties undertake, as provided for in Part III, to consider themselves bound by the obligations laid down in the following articles and paragraphs.
			Part#II.11 With a view to ensuring the effective exercise of the right to protection of health, the Parties undertake, either directly or in cooperation with public or private organisations, to take appropriate measures designed inter alia:
			Part#II.11.3 to prevent as far as possible epidemic, endemic and other diseases, as well as accidents.

			XI Every person has the right to the preservation of his health through sanitary and social measures relating to food, clothing, housing and medical care, to the extent permitted by public and community resources

		<b>ACHR</b> American Convention on Human Rights	<b>Show all articles</b> 4.1 Every person has the right to have his life respected. This right shall be protected by law and, in general, from the moment of conception. No one shall be arbitrarily deprived of his life.
		<b>Protocol of San Salvador</b> Additional Protocol to the American Convention on Human Rights in the Area of Economic, Social and Cultural rights (Protocol of San Salvador)	<b>Show all articles</b> 10.1 Everyone shall have the right to health, understood to mean the enjoyment of the highest level of physical, mental and social well-being.
			10.2 In order to ensure the exercise of the right to health, the States Parties agree to recognize health as a public good and, particularly, to adopt the following measures to ensure that right:
			10.2.a Primary health care, that is, essential health care made available to all individuals and families in the community;
			10.2.b Extension of the benefits of health services to all individuals subject to the State's jurisdiction;
			10.2.c Universal immunization against the principal infectious diseases;
			10.2.d Prevention and treatment of endemic, occupational and other diseases;
			10.2.e Education of the population on the prevention and treatment of health problems,
			10.2.f Satisfaction of the health needs of the highest risk groups and of those whose poverty makes them the most vulnerable.
		<b>Convention of Belém do Pará</b> Inter-American Convention on the Prevention, Punishment and Eradication of Violence Against Women	<b>Show all articles</b> 4 Every woman has the right to the recognition, enjoyment, exercise and protection of all human rights and freedoms embodied in regional and international human rights instruments. These rights include, among others:
			4.a The right to have her life respected;
		<b>ACHPR</b> African Charter on Human and Peoples' Rights	<b>Show all articles</b> 4 Human beings are inviolable. Every human being shall be entitled to respect for his life and the integrity of his person. No one may be arbitrarily deprived of this right.
			16.1 Every individual shall have the right to enjoy the best attainable state of physical and mental health.
			16.2 States parties to the present Charter shall take the necessary measures to protect the health of their people and to ensure that they receive medical attention when they are sick.
		<b>ACRWC</b> African Charter on the Rights and Welfare of the Child	<b>Show all articles</b> 14.1 Every child shall have the right to enjoy the best attainable state of physical, mental and spiritual health.
		<b>Maputo Protocol</b> Protocol to the African Charter on Human and Peoples' Rights on the Rights of Women in Africa	<b>Show all articles</b> 14.1 States Parties shall ensure that the right to health of women, including sexual and reproductive health is respected and promoted. This includes:
			14.1.d the right to self-protection and to be protected against sexually transmitted infections, including HIV/AIDS;
			14.1.e the right to be informed on one's health status and on the health status of one's partner, particularly if affected with sexually transmitted infections, including HIV/AIDS, in accordance with internationally recognised standards and best practices;
