			<p>7.5 The public participation procedure will provide for reasonable timeframes that allow sufficient time to inform the public and for its effective participation.</p>

Before adopting the decision, the relevant public authority shall give due consideration to the outcome of the participation process.</p>
			<p>7.9 The dissemination of the decisions resulting from environmental impact assessments and other environmental decision-making processes in which the public has participated shall be carried out through appropriate means, which may include written, electronic or oral means and customary methods, in an effective and prompt manner.
